Sir,

The undersigned has been appointed as an Administrator cum Returning Officer of Asha Deep Cooperative Group Housing Society Ltd. Dwarka vide RCS Office letter F.No – 47/ 1290/ GH / OOP/ RCS/ 124 – 126 dated 12.02.2024 to manage the affairs and to hold the election of the Managing Committee of the society within 90 days.

It is to state that the CBI had seized a number of documents of the society including the original Membership Register on the 25th January, 2007. It is to mention that for holding a valid election, and authentic Membership Register is required, which is not available in the office of the society and in the absence of and authentic Membership register, preparation of an electoral roll would be difficult.


Accordingly, the undersigned has approached to SP, CBI, ACB, New Delhi, vide letter no. DOE/ASHADEEP/RCS/2023/ dated 22.02.2024 (copy enclosed) to return the original Membership Register of the society to enable the undersigned to hold elections of the society.

The Supdt. of Police, CBI, ACB, New Delhi vide letter no. RC. 47(A)/2006/CBI/ ACB/ Delhi (copy enclosed) dated 18.04.2024 has informed that after investigation the documents of the instant case were deposited in the concerned court. Vide judgment dated 28.08.2021, the said case was disposed of by the Hon'ble Special Court (CBI), RACC, New Delhi and advised that the concerned court of Hon'ble Special judge (CBI), RACC, New Delhi may be approached to get the required documents.

It is, therefore, requested that the original Membership Register of the society may kindly be return to enable the undersigned to hold elections of the society within the prescribed time. If the Hon'ble Court still needs the original Membership Register, the same would be returned after the completion of the election process to elect a new Managing committee.


