Sub: **Forged signatures of three members deliberately in the application addressed to the undersigned**

Ref:- **Complaint made by Mr. DPS Rajesh, Membership No.-205.**

With reference to said subject matter, you along with other so called 18 members of the society were assembled in the community hall of the society on 03.03.2024 at 11 AM to discuss the issue of conducting election of the society. All so called 18 members have put their signatures on the letter/representation addressed to the undersigned. It shows that the members, who have put their signatures were physically present in the meeting.

One member namely Mr. D.P.S Rajesh, Membership No.- 205 have made a complained stating that:-

"Please refer to the letter in the handwriting of Shri Ramesh Kumar Prabhakar appears to have been signed by the 18 members of the society addressed to you regarding your prior intimation to the signatories about your presence in the society. It is relevant to mention that the signatures of Smt. SarojVashishth, Shri Harish Kandpal and Shri Parkash Chand Pandeyout of the 18 members' signatures are forged. The fact may kindly be verified that these members didn't attend the meeting but still their signatures figure in the application address to you. It is requested that you may consider taking legal action against the culprits under Sections 120B (criminal conspiracy), 463 (forgery), 464 (making a false document) and 470 (forged document).

The allegation levelled by the complainant are of serious in nature. You must be aware that deliberately forging anyone's signature on any document with bad intentions falls under the category of a very serious crime under Indian Penal Code, 1860. In this way, any person can misuse the property documents by forging the signature of any person and can also claim the property. This is the reason why there is a provision of strict punishment for forging signature in Indian law.

Keeping in view of the seriousness of the allegations, the undersigned have gone through the personnel files of these three members and found that the signatures put on the letter is totally different than the signatures available in the personnel files of these members.

Hence, you are directed to kindly provide concrete proof (i.e. videography of the meeting, CCTV Footage etc) showing the presence of the said three members in the meeting with detailed explanation on or before 28.03.2024.
