REG- REPRESENTATION IN RESPECT OF IRREGULAR PAYMENT TO THE CONTRACTOR - RECOVERY THEREOF AS PER THE DECISION OF THE SPECIAL GENERAL BODY MEETING HELD ON THE 21ST APRIL, 2024

Sir

Please refer to your letters issued to the erstwhile MC members including me in this regard for recovery of irregular, unauthorized and unapproved payment to the contractor in the name of escalation cost. I want to bring the following facts in your knowledge for consideration:-

1. That the fact of having issued & handing over the cheque to the contractor on 02/08/23 i.e. before approving it on 05/08/23 in MC's alleged meeting came to my knowledge now only. This fact was concealed by them when the enhancement was approved on 05/08/23. How I am accountable/responsible for the payment which had already been made i.e. before 05/08/2023.
2. The minutes/resolution of the MC meeting were used to be prepared by one or two persons and thereafter they use to get it signed from me at my home even if whenever I was not present in the meetings.
3. When I sought clarification in respect of minutes and resolution dated 05/08/23 and advised them to get it passed in the AGM first, they assured me that it is in conformity with Law and I need not worry if anything adverse happens I will not be held responsible. On their assurance I signed the documents. Even at this point of time they did not disclose the fact that the payment to the contractor has already been made. They concealed this fact from me. Had I been told about this fact, I would have not signed on resolution dated 05/08/23. Hence, the persons who have released the payment before 05/08/23 are responsible. Had the payment been made after 05/08/23 only then I would have been responsible.
4. It has also come to my notice now that they are giving reply to your letters and are mentioning my name also as if that it is on my behalf. They are doing it deliberately and without my consent. *I had asked for four weeks extension for reply.*
5. As I was kept in the dark and usually they use to get the minutes signed from me separately afterwards, my intention was bonafide.
